TMG PARTNERS PLANS REDEVELOPMENT OF CALIFORNIA PACIFIC MEDICAL CENTER/SUTTER HEALTH, CALIFORNIA CAMPUS

Developer Submits Preliminary Project Application and Environmental Evaluation for up to 250 Units in Presidio Heights

SAN FRANCISCO (March 17, 2017) – TMG Partners, one of the San Francisco Bay Area's largest mixed-use property developers, today submitted a Preliminary Project Application and Environmental Evaluation for a proposed residential project at the California Pacific Medical Center (CPMC) Sutter Health, California Campus. The proposal for up to 250 units was informed by an 18-month community visioning and planning process.

"TMG prides itself on working with local communities to develop unique plans for projects that reflect the surrounding neighborhood and we look forward to continuing this close neighborhood planning work as the process unfolds with the City," said Matt Field, Chief Investment Officer, TMG Partners. "We are proud of the carefully thought-out, family-oriented design that we submitted today to launch the official public process. We are also very grateful for the hours spent by the dedicated neighbors who are working with us to weave this new development into the existing neighborhood."

The project, designed by the renowned architecture and urban planning firm Robert A.M. Stern Architects (RAMSA), carries forward the architectural character of the surrounding neighborhood. The proposal is one of the few new projects in San Francisco to be oriented towards family housing, with more than 80% of units having two or more bedrooms. The RAMSA plans feature almost 40 individual townhouses and apartment buildings, ranging from 35 to 80 feet in height, consistent with site zoning and the scale of the surrounding neighborhoods. Building heights, setbacks, rooflines, and architecture were carefully tailored based on discussions between the project team and neighbors. Adequate parking has been provided below ground to keep cars off city streets.

The project's design team developed its proposal through eighteen months of interactive design meetings with project neighbors, including a Visioning Advisory Committee made up of neighborhood association representatives, as well as with San Francisco City staff. The designs

reflect the housing types surrounding the project site rather than a generic "project" that could be anywhere.

"TMG has been an ideal development partner," added Jenifer Turnbull, VP Facility Development, Sutter Bay Area. "They have closely and carefully worked with the local community to develop a well-supported project of which CPMC/Sutter Health is proud."

The Project includes:

- Demolition of most existing CPMC/Sutter Health hospital facility buildings
- Conversion of the original Marshall Hale building at 3698 California to residential uses
- Retention of the existing 401 Cherry apartment building and current residents
- Construction of up to 37 new buildings, below-grade parking, and project amenities
- Building heights of approx. 35'-80' and 3-7 stories.
- Up to 250 units with plans currently showing 240 units including 26 single-family homes and 214 multi-family units
